# 3.Incorporation and 501 c3:

Sandy, the Virtual Region Treasurer to discuss becoming a 501 c3 now that we are an intergroup. This is an option, not a requirement, for us moving forward.

Our organization and treasury are currently tied to personal accounts. The 501 c3 allows for some integrity and protection.

Sandy discussed the Pros and Cons of the incorporation of 501 c3.

She did not seem to recommend it, if you didn't support a lot of cash: meaning 10,000-20,000 dollars a year. Creates lots of paper work

Possibly can give us a liability shell only if we carried insurance, in filing state taxes, those associated with the treasury and on the board will need to give full names and SS numbers.

May give us some integrity.. It would require a registered agent which is a registered address for the IRS to send mail.

To incorporate and become 501 c3:

- file application (fee is \$275)
- file taxes annually (no payment, just filing).
- -Registered agent in the state that we incorporate. Many do New Mexico, because that is where OA World Service is located.
- PO Box can be in any state. usually a business like Staples. Forwards mail to treasurer. Fee for the box and each mail forward.

We did not discuss if we wanted to do this or not. Will need to be discussed at the next business meeting. 10/1/202

## **NEW BUSINESS**

1. Saying HP instead of "God" when saying the Serenity prayer or Steps.

After much discussion it was decided to leave as written and if someone changes the wording, the Leader will privately let member know of our group conscience to read as written and not replace the work God.
