2. Does the Bridge want to be added to oa.org multiple addiction dropdown list? (which is not in effect as yet) – Virtual Region
  - Lisa reports that it has already been approved and reads from the minutes of April 7, 2024: "Gary who is on the Board of Trustees asks Ellen and Mary Jane to send an email with all the Bridge information to be added for Advanced Search on the OA website. Suggests using Multi-Addictive Compulsive Eater as the heading and to include all meetings in person and virtual. Multi - Addictive Compulsive Eater was suggested for it clearly tells what kind of meeting we are, ex Newcomer, 100 lb'er, etc. Motion was made and passed unanimously

3. Posting VR "Interview" recording of the Bridge interviews from August 25, 2024 on Bridge website.
  - The Virtual Region will not post the recording as they contain references to other twelve steps programs outside of OA and this would violate tradition 10, "has no opinion on outside issues."
  - The Bridge, of course, is multiple 12 step programs and could post this.
  - The effort to get this recording would include making an appeal to the VR board to get permission, and the group decides not to go through with this.
